



NEWS: Over 50 Organizations and Unions Endorse #SaveTheACA Rally in Downtown LA

LOS ANGELES – Over fifty organizations and unions have endorsed the #SaveTheACA rally and march scheduled to take place on March 23rd in downtown Los Angeles. The groups, ranging from the ACLU to SEIU, will stand side by side with neighbors and allies to fight back against threats to repeal or dismantle the Affordable Care Act (ACA). “In today’s political climate, it seems impossible to find common ground -- but these groups are joining forces because they all agree: health is a fundamental human right,” said Jim Mangia, President & CEO of St. John’s Well Child and Family Center. “This kind of widespread participation sends a clear message to politicians who are willing to play politics with people’s livelihood: we will not stand for it. We will fight for our families, our friends, and our neighbors.”

Thousands are expected to join the march, being held on the seventh anniversary of the ACA’s passage, to stand up for the millions who have gained insurance, lifesaving treatment and preventative care through the ACA’s passage.
